Procedure for Sales

We have received your intent to sell, once you have a buyer the following must be submitted to the office as soon as possible.

- 1. Copy of the signed Purchase and Sale (once you have a buyer)
- 2. Because some closing dates are rescheduled earlier than the original closing date stated on the Purchase & Sale and mail delivery delays your condo fee must be paid for the month you are closing with a Bank Check or Money Order, NO EXCEPTIONS, that is the only way to guarantee that the closing will not be delayed waiting for checks to clear.
- 3. You will need a 6-d Certificate, the fee is \$50.00. Do to the fact that some closing dates are rescheduled earlier than the original closing date stated on the Purchase & Sale and mail delivery delays, a Bank Check or Money Order Only. NO EXCEPTIONS, that is the only way to guarantee that the closing will not be delayed waiting for checks to clear.

 The 6-d Certificate relieves concerns about unpaid condo fees. Mass. General Laws Ch. 183A, sec. 6(d) shall be furnished within 10 business days after receipt of a written request and payment for the 6-d certificate.
- 4. If you have auto withdrawal set up for your condo fee payments it is your (seller/(s) responsibility to cancel the auto withdrawal.
- 5. Please return pool fob and coupon book. If you have a copy of the rules, regulations and by-laws (3 ring binder) please leave it in the unit for the new buyer.

The buyer must set up an orientation meeting with the office (we will notify the buyer by mail once we receive a copy of the Purchase and Sale).

- a. If for any reason the closing is delayed into the next month, you will need to pay an additional condo fee for that month and you will also need an updated 6 (d) Certificate. Both additional condo fee and 6-d will need to be paid with a Bank Check or Money Order. NO EXCEPTIONS.
- b. Reminder: Please don't forget to leave all the keys for the buyer for your condo, storage room, garage doors, garage remotes and mailboxes, we do not have keys for any condos. The U.S. Post Office fee for a Lock Change for mailboxes is \$35.00 for 2 keys.
